## AJC Welcomes Long-Overdue Return of Hostages



After 738 days, the American Jewish Committee (AJC) is overjoyed watching the reunions of the 20 surviving hostages with their loved ones, and our hearts are with the families of the deceased hostages who await their return.

As we welcome home 20 of the 48 hostages, we hope that we will very soon be able to say that all 48 – Tamir Adar, Muhammad Al-Atarash, Matan Angrest, Sahar Baruch, Uriel Baruch, Gali Berman, Ziv Berman, Elkana Bohbot, Rom Braslavski, Itay Chen, Nimrod Cohen, Amiram Cooper, Ariel Cunio, David Cunio, Evyatar David, Ronen Engel, Guy Gilboa-Dalal, Meny Godard, Hadar Goldin, Ran Gvili, Tal Haimi, Asaf Hamami, Inbar Hayman, Maxim Herkin, Eitan Horn, Guy Illouz, Bipin Joshi, Segev Kalfon, Bar Kupershtein, Eitan Levi, Eliyahu Margalit, Omri Miran, Joshua Luito Mollel, Eitan Mor, Omer Neutra, Tamir Nimrodi, Yosef-Chaim Ohana, Alon Ohel, Sontia Ok'Krasari, Avinatan Or, Dror Or, Daniel Oz, Daniel Perez, Sontisek Rintalk, Lior Rudaeff, Yossi Sharabi, Arie Zalmanowicz, Matan Zangauker – are finally back home.

As we welcome home the surviving hostages and mourn with the families of deceased hostages as they wait to bury their loved ones, we must ensure full rehabilitation for the living and the continued support for all the families who have endured extensive trauma and grief.

AJC is both proud of and humbled by the trust hostage families and previously rescued and returned hostages have placed in us, allowing us to advocate with them across the United States and around the world to keep their stories front of mind for officials at the highest levels of government and across civil society. Their strength, determination, and selflessness are an inspiration and the Jewish people around the world are standing with them as this darkest chapter comes to a close.



## **Anne Frank the Exhibition Unveils Vital Antisemitism Curriculum**

Anne Frank The Exhibition is launching an innovative curriculum to confront antisemitism across the United States, in response to extraordinary interest from middle and high schools since its debut on International Holocaust Remembrance Day 2025. This new initiative powerfully responds to teachers' urgent calls for classroom resources that address the full spectrum of antisemitism, from its historical roots to current manifestations. This bold educational commitment solidifies the Anne Frank House's role as a global leader in education, dedicated to combating antisemitism, racism, and discrimination and empowering the next generation to actively challenge hatred and prejudice.

Anne Frank the Exhibition will distribute an additional 20,000 free copies of Anne Frank: The Diary of a Young Girl to students in New York City and Long Island public schools this year, in addition to the 10,000 diaries distributed over the summer. This initiative further extends access to Anne Frank's powerful story, reaching thousands more students beyond those who have already engaged with the exhibition this year. This strengthened collaboration with New York City Public Schools—with the distribution of 20,000



copies of Anne Frank: The Diary of a Young Girl—is made possible thanks to the generosity and leadership of UJA-Federation of New York, Heckscher Foundation for Children, and Einstein Astrof Foundation, with additional support from Melik-Baschkopf Foundation and the Slome Family.

This news follows the announcement

of the final exhibition extension at the Center for Jewish History, 15 West 16th Street, New York City, through February 1, 2026, and complimentary enhanced access days for families, educators, librarians, and select groups (eligibility information below) on November 4th (Election Day) and November 11th (Veterans Day).


"In response to the urgent needs voiced by teachers and students who have experienced Anne Frank The Exhibition, the Anne Frank House has developed a new antisemitism curriculum. Driven by an obligation to meet educators and learners where they are, this curriculum provides practical tools for confronting antisemitism, past and present, and helps foster a personal sense of responsibility in standing against hate. To ensure meaningful classroom impact, we are offering training sessions with our expert education team, empowering educators to guide students in building a more just and compassionate world," said Ronald Leopold, Executive Director of the Anne Frank House.

Educators can access the curriculum, specifically designed for secondary students, through the Anne Frank The Exhibition website. Teachers are invited to register for free sessions with education experts from the University of South Carolina for personalized guidance on delivering these lesson plans, tailored to student needs, classroom rigor, and readiness to address antisemitism.

As noted when the exhibition was extended, New York State Education Commissioner Betty A. Rosa said, "Anne Frank The Exhibition provides a profound educational experience that connects the lessons of history to the challenges and responsibilities of today. It provides students with a meaningful opportunity to explore the realities of antisemitism and intolerance while equipping educators with resources to thoughtfully integrate these lessons into their instruction. This exhibition not only honors the memory of Anne Frank and her family but also strengthens our shared responsibility to ensure that future generations learn the importance of empathy, tolerance, and standing against hate in all its forms.

"Anne Frank's diary gives voice to the hopes and fears of a young girl facing unimaginable hatred — and that voice still speaks powerfully to young people today," said Eric S. Goldstein, CEO, UJA-Federa-

tion of New York. "By helping to put this book directly into the hands of students, we're giving them the opportunity to connect personally with Anne's story, reflect on the consequences of hatred, and understand the possibility of resilience and the human spirit. Particularly now, at a time of sharply rising hatred targeting the Jewish community, our hope is that young readers will be inspired to stand up to hate, to find courage in the face of adversity, and to believe in the power of their own voices."

With the launch of a curriculum designed for educators across the United States, the Anne Frank House reaffirms its mission: to keep Anne's story and voice alive and to educate new generations to stand against antisemitism, racism, and all forms of discrimination.

Special Access Days with complimentary admission

General admission tickets are available every day the exhibition is open, and enhanced complimentary admission will be offered to select visitors on the following dates:

November 4 (Election Day): All-day access for families, Hometown Heroes, educators, and librarians.

November 11 (Veterans Day): All-day access for families, Hometown Heroes, educators, and librarians.

Official ID and email are required for police officers, firefighters, first responders, medical professionals, military per-

sonnel, educators, and librarians for free admission on special access days. Tickets for special access days are available with day-of on-site registration.

Anne Frank The Exhibition is the first time in history that the Anne Frank House presents a pioneering experience outside of Amsterdam to immerse visitors in a full-scale recreation of the Annex rooms, fully furnished, where Anne Frank, her parents and sister, and four other Jews spent two years hiding to evade Nazi capture.

Four exhibition galleries immerse visitors in place and history through video, sound, photography, and animation; and more than 100 original collection items from the Anne Frank House in Amsterdam. Anne Frank The Exhibition provides an opportunity to learn about Anne Frank not as a victim but through the multifaceted lens of her life—as a girl, a writer, and a symbol of resilience and strength. This is a story inspired by one of the most translated books in the world.

Artifacts in the exhibition include:

- Anne Frank's first photo album (1929-1942);
- Anne Frank's typed and handwritten invitation to her friend for a film screening in her home (by 1942, anti-Jewish measures prohibited Jews from attending the cinema); and
- Handwritten verses by Anne Frank in her friends' poetry albums.

## AJC Addresses Anti-Semitism on Campus

As part of the American Jewish Committee's (AJC) Center for Education Advocacy's (CEA) strategic partnerships with leading universities, AJC CEO Ted Deutch met with Washington University Chancellor Andrew Martin in September to discuss the educational reform initiative, "A Return to Principles," co-authored with Vanderbilt Chancellor Daniel Diermeier, which has garnered national attention for its commitment to academic excellence and institutional integrity. Chancellor Martin shared his approach to addressing campus antisemitism and creating an environment where all students can learn without fear or intimidation.

Over the past three months alone, CEA conducted 19 high-level meetings with presidents and chancellors at Ivy League schools, large public research institutions, and liberal arts and faith-based colleges. This engagement produces tangible results, helping universities develop strategies for culture change and adopt items from AJC's action plan to address campus antisemitism.



## Westchester County Board of Legislator Invests in Youth Employment, Mental Health Services, and Historic Preservation

The Westchester County Board of Legislators approved measures to create summer work experience for young adults, expand employment services for people with mental illness, and acquire a Revolutionary War landmark at its meeting on Monday, September 29.

Board Chairman Vedat Gashi (D-New Castle, Ossining, Somers, Yorktown) said, "The Board's actions Monday night show we're thinking about every member of our community—from young people building their first job skills to adults seeking employment support to families looking for places to connect with our history. The County is investing in opportunities that matter to the people of Westchester."

#### Summer Program to Help Young Adults Build Career Skills and Earn Income

The Board approved agreements with eight municipalities to provide a six-week summer work experience program for youth ages 16-24 from income-eligible families. The program offers participants more than just a paycheck—they'll develop workplace skills, build professional networks, and gain valuable contacts that will serve them throughout their careers. Fully funded by a \$150,000 grant from New York Presbyterian Hospital, the program incurs no direct cost to county taxpayers. The Westchester County Youth Bureau will coordinate with local youth bureaus in Mount Vernon, New Rochelle, Peekskill, Yonkers, White Plains, Ossining, Port Chester, and Greenburgh.

Minority Whip James Nolan (R-Yonkers, Eastchester, Bronxville), Chair of the Board's Veterans, Seniors and Youth Committee, agreed and said, "I'm proud to support expanded summer employment and training opportunities for our youth here in Yonkers. Our young people are the most valuable resource we have. Programs like this not only provide early job experience and mentorship, but also help build confidence, responsibility, and community engagement. Investing in youth is investing in the future of Westchester."

## Mental Health Employment Services Expanded

The Board also approved expanded support for adults with serious mental illness to find and maintain jobs. The initiative includes job coaching, rapid placement assistance, and connections to community employers. New York State is providing an additional \$244,858, increasing total funding to \$1.39 million through 2026. Westchester

Medical Center administers these services, helping participants build independence and achieve financial stability.

Legislator Nancy E. Barr (D-Harrison, Port Chester, Rye Brook), Chair of the Board's Human Services Committee, said, "Finding and holding a job is an important milestone for most adults, providing both a livelihood and a sense of self-worth. But for adults affected by serious mental illness, this can be very challenging. I am pleased that we are now able to increase funding to support these job seekers with money from the NYS Department of Mental Health. Helping these individuals find and maintain appropriate employment is a win-win, and we are fortunate to be able to partner with WCHCC to administer this program."

#### Preserving Revolutionary War Heritage

In addition, Westchester residents will soon be able to experience a rare piece of living history at the historic Ward House in Tuckahoe, following the Board's approval to acquire the property. The \$2.55 million bond authorization will purchase the Revolutionary War-era property on White Plains Road for \$980,000 and fund renovations to make the site welcoming and accessible to the public. This investment ensures that an authentic glimpse into 18th-century life becomes a community asset for generations to come.

Built more than 270 years ago, the Ward House served as home to Stephen Ward, Eastchester's Town Supervisor in the 1700s, and played a significant role during the Revolutionary War. After British General William Tryon burned the structure, Ward's son Jonathan restored it—preserving a tangible connection to the County's colonial past.

Legislator Judah Holstein (D-Eastchester, New Rochelle, Tuckahoe) said, "I am immensely pleased and proud that we have approved the purchase of the Ward House in Tuckahoe, ensuring that this important Revolutionary War landmark will be preserved. This investment safeguards a rare piece of our colonial history and makes it possible for future generations to connect with the story of our nation's founding right here in Westchester and in District 10. ## Westchester County Office for Women Hosts 23rd Annual Police Interactive Training Conference



The Westchester County Office for Women held its annual Police Interactive Training Conference, a keystone event during October's Domestic Violence Awareness Month. The theme of the conference was "Saving Lives ... a Growing Westchester Partnership" and the objective was to provide police officers who respond to domestic violence incidents with best practices for safe outcomes for victims. Over 300 individuals were in attendance from the Westchester County Department of Probation, community partner agencies, service providers and representatives from 34 police departments County-wide.

The comprehensive program featured a keynote entitled "Leading with Courage and Compassion: The Guardian-Warrior Path in Policing." It detailed the retired NYS Police Senior Investigator Matthew Stegner's journey to prioritizing domestic violence cases, and emphasized the need for officers to embody and balance the "warrior" and the "guardian" when interacting with victims. The audience heard updates from the County's Domestic Violence High Risk Team (DVHRT) on current cases, the first time testimonial of a survivor, a review of how to implement existing and amended NYS laws and a report from the County's Gun Violence Task Force detailing the intersection of gun safety and domestic violence.

In addition, several awards were presented: a survivor and volunteer advocate received the Blue Bird Survivor Leadership award, ADA Joyce Miller received the James Cannon award for excellence in the field and Office for Women Director Robi Schlaff received the DVHRT Leadership Award.

Westchester County Executive Ken Jenkins said: "The Police Interactive Training Conference is where you see first-hand the incredible results of bringing together the right stakeholders to assist domestic violence survivors. Building bridges between law enforcement and community providers is essential to making inroads into this dangerous issue. This is why other counties and communities are reaching out to replicate our outstanding model. Westchester County stands committed to investing in domestic violence prevention efforts."

Westchester County Department of Probation Commissioner Rocco Pozzi said: "Domestic violence impacts individuals across all ages, genders, and backgrounds, leaving lasting effects on families and communities. ### Why Safe Deposit Boxes May be Creating More Problems Than Protections

For generations, families relied on bank safe deposit boxes to safeguard important documents, jewelry, and sentimental heirlooms. Having a key to a safe deposit box once symbolized prudence and financial responsibility. But in today's world of digital records, cloud storage, and home safes, these boxes are not only outdated but they can create serious legal and practical challenges, especially after a death. Understanding how safe deposit boxes work, and how access is handled when an owner or co-owner dies, can prevent costly delays and emotional frustration for loved ones.

When a person who rents a safe deposit box dies, the box and its contents are typically sealed by the bank. Financial institutions do this to protect themselves from liability and to ensure that only an authorized person, usually the executor or administrator of the estate, can access the contents. The problem is that the executor often cannot be appointed until the Will is submitted to the Surrogate's Court for probate, and the original Will is often inside the box. This circular dilemma can delay probate for weeks or months.

In New York the Estates, Powers and Trusts Law (EPTL) allows limited access to a decedent's safe deposit box for specific purposes, such as retrieving a Will, burial instructions, or a life insurance policy. However, the bank must follow a prescribed procedure and require proper identification and usually a court order before opening the box. The process takes time, particularly if the family is unaware that the box exists or cannot locate the key.

Many people assume that naming a joint owner on a safe deposit box will avoid these problems. Unfortunately, that is not always the case. A "joint tenant" has full access during both parties' lifetimes, but once one owner dies, banks often restrict access until proof of death and estate documentation are provided.

This happens because the contents of the box may not actually belong to the surviving joint owner, even if their name appears on the box. The legal question becomes one of ownership: were the contents

jointly owned, or did the deceased simply grant access for convenience? In some cases, the court appointed executor must provide a full inventory of the contents before removing anything, to prevent misappropriation of estate assets.

Beyond the access issues, safe deposit boxes themselves are quietly disappearing. Many major banks no longer offer them at new branches, and some have stopped renting them altogether. Maintaining secure vaults is expensive and labor-intensive, and today's consumers increasingly prefer digital or in-home alternatives.

Many of the reasons people once used safe deposit boxes, including storing original deeds, stock certificates, savings bonds, or important legal documents, no longer apply. Most records are now maintained electronically or can be easily replaced. What cannot be replaced is your original estate-planning documents which should be kept somewhere immediately accessible to your fiduciaries, not behind a locked door in a bank vault.

Branch consolidations also pose a risk. As banks close or merge, box holders may be notified that their branch is shutting down and must remove their contents by a deadline. If the notice is missed or goes to an old address, the contents can end up in the state's unclaimed property system, creating another layer of complexity for heirs.

For most people, a well-secured home safe offers a more practical and accessible option. Fireproof and waterproof safes rated for at least one hour of fire resistance can protect critical papers and valuables. Originals of your last will and testament, power of attorney, health care proxy and any trusts should be stored there, while your attorney should maintain copies.

It's also wise to maintain a written inventory of what's in the safe, share its location with your executor or trusted family member, and ensure that someone knows the combination or where to find it in the event of an emergency.

Digital storage is another alternative. Many law firms now provide secure client portals, and reputable online vaults offer encrypted storage for scanned copies of legal documents, insurance policies, and passwords. However, digital storage should supplement, not replace, properly executed original documents.

Safe deposit boxes once represented the height of security and orderliness, but in modern estate administration they often cause the opposite: inaccessibility, delay, and confusion. Families can avoid these complications by understanding how banks handle access at death, reconsidering whether a box is necessary, and ensuring that essential documents remain easily

accessible to those who will need them most. By modernizing how you store and safeguard your important papers, you can give your loved ones the true peace of mind that safe deposit boxes were once meant to provide.



#### American Jewish Committee Applauds Increased Support for Holocaust Survivors from Claims Conference and German Government

American Jewish Committee (AJC), the global advocacy organization for the Jewish people, welcomes today's announcement from the Claims Conference and the German government that close to one billion euros will be allocated in 2026 to provide much-needed home-care assistance for Holocaust survivors.

AJC is a founding member of the Claims Conference, which negotiated its first agreement with the German government on behalf of Holocaust survivors in 1952. In recent years, the Conference has focused on securing funding specifically for home-care assistance for aging survivors, as the most needy and infirm are homebound.

More than 100,000 survivors, with an average age of 88, receive this assistance through the Claims Conference, funded by Germany, and provided by Jewish social service agencies in the United States and around the world and the National Health Service in Israel.

"It is noteworthy that through-

out these years and despite changes in government coalitions and priorities, Germany has never wavered in shouldering its responsibility to address the needs of Holocaust victims," said Rabbi Andy Baker, AJC Director of International Jewish Affairs, who has been a member of the Conference negotiating committee for the past two decades.

In addition to the home-care funding, more than 150 million euros will support Holocaust education efforts across the globe over the next four years. This is especially important at a time when Holocaust distortion is spreading, and even rudimentary knowledge is lacking among large segments of the population, as identified in recent American Jewish Committee and Claims Conference surveys.

According to AJC's State of Antisemitism in America 2024 Report, the majority of U.S. adults do not know that six million Jews were murdered during the Holocaust (52%) or that Hitler came to power through a democratic political process (60%).

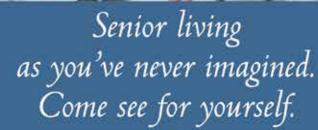
